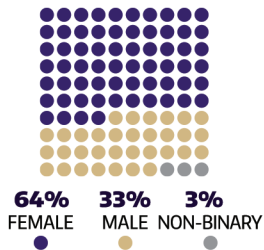

GENDER BREAKDOWN



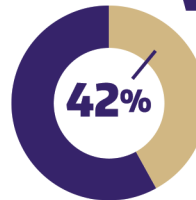

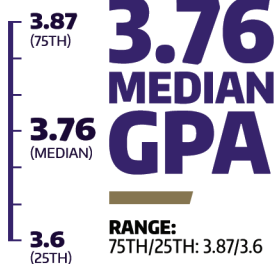

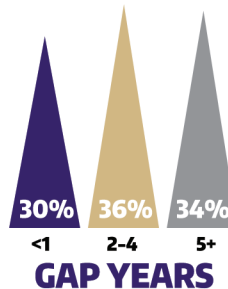

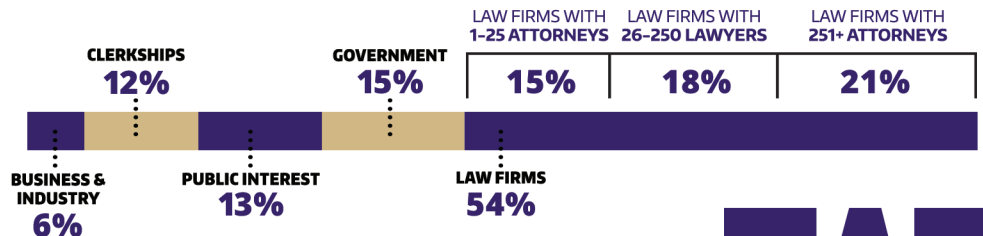
